THE SYMPHONY IS A 75-MEMBER REGIONAL ORCHESTRA WHICH PERFORMS CONCERTS IN THE CAILLOUX THEATER FOR THE PERFORMING ARTS IN DOWNTOWN KERRVILLE. THE SYMPHONY PERFORMS FOUR CLASSICAL CONCERTS, TYPICALLY IN THE MONTHS OF OCTOBER, DECEMBER, FEBRUARY AND APRIL AND A POPS CONCERT IN JANUARY. IN ADDITION, IT PERFORMS TWO CHILDREN'S CONCERTS IN OCTOBER, DRAWING ON THE CONTENT OF THAT MONTH'S EVENING CONCERT. OVER THE YEARS, THE REPERTOIRE HAS INCLUDED SYMPHONIES, TONE POEMS, OVERTURES AND CONCERTOS FROM THE MUSICAL CANON OF THE WESTERN WORLD. PIECES WITH CHORAL CONTENT ARE ALSO COMMON, EMPLOYING A GRAND CHORUS. THE POPS CONCERT CHARACTERISTICALLY PRESENTS MUSIC FROM BROADWAY AND FILM AND THE REALM OF POPULAR CLASSICS, SOMETIMES IN TANDEM WITH SINGERS OR SMALL POP ENSEMBLES. THE ANNUAL CHILDREN'S CONCERTS BRING OVER 1600 ELEMENTARY

WE STRONGLY BELIEVE THAT THERE IS A NEED TO INTRODUCE YOUNG PEOPLE TO THE GRANDEUR OF TRADITIONAL CLASSICAL MUSIC AND TO ENCOURAGE THEIR OWN INCLINATIONS TO CREATE MUSIC. FOR THAT REASON, OVER THE PAST 12 YEARS WE HAVE BEEN PERFORMING TWO CHILDREN'S CONCERTS EACH SEASON FOR ALL 3RD AND 4TH GRADE STUDENTS IN THE KERRVILLE AREA, FOR A TOTAL OF MORE THAN 1600 STUDENTS ANNUALLY. THE OBJECTIVE OF THIS PROGRAM IS TO FAMILIARIZE ELEMENTARY SCHOOL STUDENTS WITH TRADITIONAL CLASSICAL MUSIC AND THE PRINCIPAL MUSICAL INSTRUMENTS OF A SYMPHONY ORCHESTRA. THE PROGRAM PROVIDES FOR SEVERAL WEEKS OF IN-SCHOOL PRESENTATIONS AND TEXAS ESSENTIAL KNOWLEDGE AND SKILLS (TEKS) COMPLIANT LESSON PLANS FOR THE TEACHERS AT EACH OF 12 SCHOOLS DESIGNED TO PREPARE THE STUDENTS FOR THEIR ATTENDANCE AT ONE OF THE TWO CHILDREN'S CONCERTS.
